

# 2016 PAHRUMP VALLEY WINERY GRAPE STOMP

## VENDOR APPLICATION, TERMS & CONDITIONS.

### GENERAL POLICIES:

- Stomp festival will be held WEATHER PERMITTING. Oct 1 & Oct 2, 2016 from 11 am until 5 pm
- Following applicant's approval, payment will be processed. No refunds will be given after approval.
- Pahrump Valley Winery reserves the right to refuse any vendor.
- All vendors must provide their own liability insurance, permits, tent, tables, displays, signage & change.
- Vendors acknowledge that electrical service is not available.
- Pahrump Valley Winery is not responsible for any accidents as well as missing or stolen items.

### BOOTH FEES

- Stomp Festival booth spaces are 10 X 10. The Winery will assign the spaces.
- Fees are \$50 per booth. This covers both days.
- No applications accepted after Sept 1, 2016. Payment due by Sept 15 after your booth has been assigned.
- Available spaces will be determined by drawing due to excessive demand.

### DUPLICATION & ORIGINALITY

The Grape Stomp Festival has very limited Vendor space. We want a diverse and unique marketplace. To avoid duplication we require a description of the merchandise you will be offering so as not to have excessive duplication.

### SET UP HOURS

Booths are to be set up Friday, Sept 30 between the hours of 9 am & 5 pm or Saturday between 7 am and 10 am.

Merchandise may be unloaded on Saturday or Sunday between the hours of 7am and 10 am only. No unloading of merchandise, tents, furniture or displays will be allowed after 10 am Saturday and / or Sunday.

### VENDOR PARKING

Parking is at a premium. Each vendor will be allowed parking for 1 vehicle only. Each vendor will be assigned a "parking pass" that MUST be displayed on the dashboard of the vehicle. Parking will be allowed ONLY in approved vendor parking areas. Parking in unauthorized areas will result in your booth closure. Each additional parking space used will require a \$10 general admission fee for each person in the vehicle.

### PASSES PER VENDOR

Each vendor will receive 2 free VENDOR PASSES per 10x10 space which must be used to enter the stomp festival. Additional vendor personnel will be required to purchase a general admission pass. Sorry, no exceptions.

### FEES, PERMITS & SALES TAX

Each vendor is responsible for any governmental permits, fees or taxes. The town of Pahrump requires a vendor license, additional fees may apply. Nye County sales tax is 7.6%. All vendors are responsible for collection and payment of applicable taxes and will hold Nevada Wine Cellars inc. dba Pahrump Valley Winery harmless for any dispute over non-payment of taxes owed.
